These areas are the Flaming Gorge National Recreation Area, Flaming Gorge Dam & powerhouse, Green River below Flaming Gorge Dam, Ashley National Forest and campgrounds. And all federal land and facilities in eastern Daggett County. The Town of Dutch John does not have an ambulance and must rely on outside service from other EMS services. These services are at least 45 minutes away from the Town. Residents and visitors are separated from life-saving, time-sensitive emergency medical services due to the geographical barriers, like the Flaming Gorge Reservoir and the Uinta Mountains.


Dear Chairman Cole and Ranking Member DeLauro:
